## **SLO COMMITTEE**

Purpose: In an effort to ensure consistency with the administration of SLO's across the district, this committee will meet to determine guidelines and procedure. This committee will work as a sub-committee of the OTES committee. A Student Learning Objective (SLO) is a measure of a teacher's impact on student learning within a given interval of instruction. An SLO is a measurable, long-term academic goal informed by available data that a teacher or teacher team sets at the beginning of the instructional interval for all students or for subgroups of students. The teacher(s) and students work toward the SLO growth targets throughout the instructional interval and use interim, benchmark and formative assessments to assess progress toward the goal. At the end of the interval of instruction, the teacher(s) meet with a principal or building team to discuss attainment of the SLO and determine the teacher's impact on student learning

- 2) SLO's are given at the following grade levels:
  - HS any teacher that is not teaching a state-tested subject area will do 1 SLO (teacher created) that will include all students they teach in a particular content area.
  - HS any teacher in their first year teaching a tested area or has no previous state-tested data.
    - Not elective courses, choose a core area taught by the teacher.
    - Include all students in the course chosen (i.e. teacher uses all English 11 students that they teach)
  - MS any teacher that is not teaching a state-tested subject area will do 1 SLO (teacher created) that will include all students they teach in a particular content area.

- MS any teacher in their first year teaching a tested area or has no previous state-tested data.
- IS teachers will use iReady
  - 3rd grade uses Math or Reading iReady.
    - A student can reach a year's worth of growth at any time during the school year
    - Student growth will be based on .75 for the year
  - 4th and 5th grade use iReady only if they are teaching a non value-added subject area or are new to the grade level/building.
- ES teachers will use iReady and teacher created SLO assessments.
  - ES teachers will use Math and Reading in iReady and the pre-approved SLO assessment.
  - iReady adjustments include:
    - A student can reach a year's worth of growth at any time during the school year
    - Student growth will be based on .75 for the year
